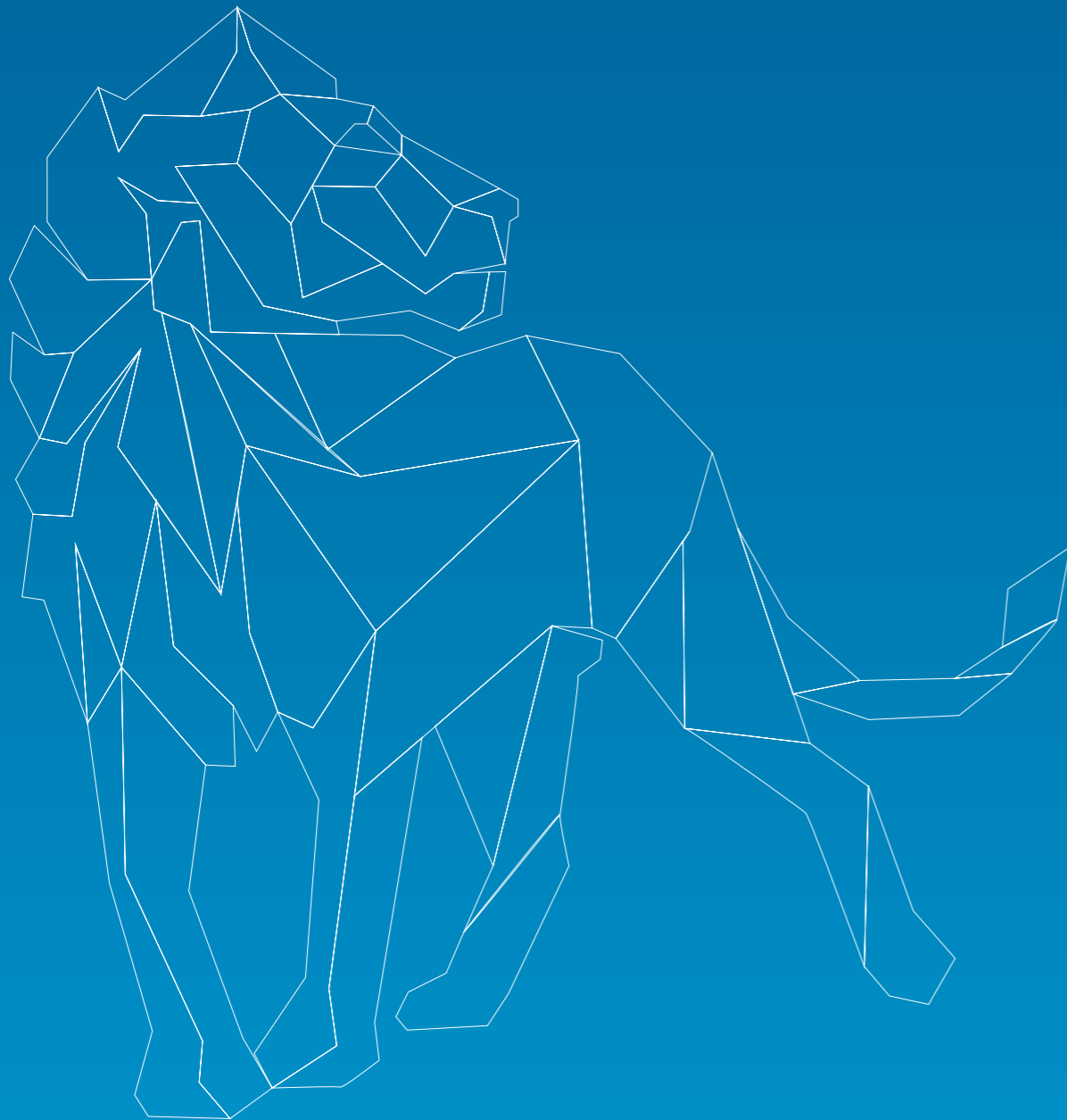

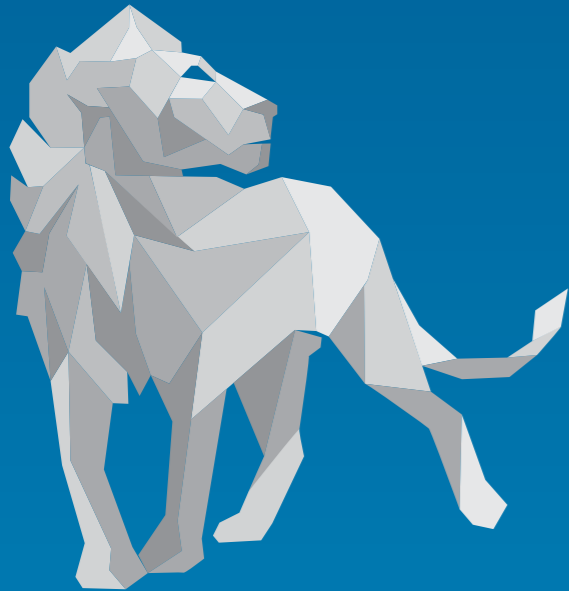

New Direction - The Foundation for European Reform is required to do the following:
I. Publish its revenue, expenditure and a statement of its assets and liabilities annually;
II. Declare its sources of funding by providing a list specifying the donors and the donations received from each donor exceeding EUR 3000;
III. Refuse anonymous donations or contributions; donations exceeding EUR 18,000 per year and per donor; donations from the budgets of political groups in the European Parliament; donations from any public authority from a Member State or a third country, or from any undertaking over which such a public authority may exercise, directly or indirectly, a dominant influence by virtue of its ownership of it, its financial participation therein, or the rules which govern it; or donations from any private entities based in a third country or from individuals from a third country who are not entitled to vote in elections to the European Parliament.
